



OFFICIAL CONTEST RULES

- 1) By entering this contest (the "Contest"), you represent and warrant that you have read, fully understand and agree to be bound by these Official Rules. You further agree to be bound by the decisions of Canadian Dental Hygienists Association (the "Company") which shall be final and binding in all respects.
- 2) The Contest is restricted to individuals who are of the legal age of majority in their jurisdiction of residence as of the date of entry in the Contest.
- 3) Entry in the Contest is prohibited to individuals residing in any jurisdiction where entry is prohibited by law.
- 4) No purchase is necessary to enter the Contest.
- 5) One (1) Contest entrant per person is permitted.
- 6) Participation in the Contest will only be permitted where such participation is legal and not prohibited. The Company makes no representations or warranties, implicit or explicit, as to your legal right to participate in the Contest nor shall any of the Company's employees, licensees, distributors, wholesalers, affiliates, subsidiaries, advertising, promotion or other agencies, media partners, agents or retailers have the authority to make any such representations or warranties.

- 12) To enter the Contest, renew or buy your CDHA membership for the 2024–2025 membership period. Your account must be in good standing during the Contest Period. For a no-purchase entry, drop off or mail a hand-drawn ballot before the end of the Contest Period indicating “2024–2025 CDHA Membership Contest” along with your full name, address, home telephone number, date of birth, and valid email address to the CDHA office located at 1122 Wellington St W, Ottawa, Ontario, K1Y 2Y7. Entries are limited to one entry per person per account. For a no-purchase entry method, one account number will be assigned per entry. The Prize will be awarded to the account holder of record only. All entries received, or if applicable post-marked after the end of the Contest Period, thereafter shall be null and void. The personal information provided on the entry forms will be collected and used for the purposes of administering the Contest awarding the Prize and announcing the winner.
- 13) The review of the Contest entries will be conducted under the supervision of the Company, whose decisions are final. On October 2, 2024, at approximately 10:00 am ET, the potential Early Bird Prize winner (the “Early Bird Winner”) will be randomly selected from all eligible entries received before October 1, 2024, at 11:59 pm ET. On November 1, 2024, at approximately 10:00 am ET, the potential Main Draw Prize winners (the “Main Draw Winners”) will be randomly selected from all eligible entries received by October 31, 2024, at 11:59 pm ET. The Early Bird Winner and Main Draw Winners shall be collectively referred to as “Winners” and individually referred to as “Winner”.

If the Company is unable to make contact with the Winner within two (2) business days, that Winner will forfeit his or her right to a Prize and a new Winner may be selected in accordance with these Official Rules. - 15) In order to receive a Prize, the Winner will be required to complete all of the following steps within five (5) days of being contacted by the Company:
 - a) Correctly answer an arithmetical skill-testing question, without assistance of any kind, whether electronic, mechanical or other;
