#### **Return to Work Guidance**

#### **CERB Extension Announced**

The Prime Minister announced that eligibility for the Canada Emergency Response Benefit (CERB) will be extended by eight weeks for those who have been getting the CERB and still can't work because they are unable to find a job, or it's just not possible. Government is looking at international best practices, monitoring the economy and the progression of the virus to see what changes if any, need to be made to the program. The Prime Minister acknowledged that some sectors will come back more quickly than others, and that while a lot of people will be able to work, not everyone will.
